The Ontario Municipal Board has removed Councillor Jason Farr from the Meadowvale Community Council Ward 3. Mr. Farr was charged with four counts of financial misconduct after the OMB conducted an audit of the accounts of the Meadowvale Community Council (MCC) from March 15 to May 2, 2016. Mr. Farr was a City of Oshawa employee and in December 2014 was elected as a City Councillor in the fall election. He was elected with 53.3% of the vote and spent almost \$100,000 on his campaign – more than any other candidate in Oshawa. The OMB is an independent tribunal made up of three independent members, a public member and an employee representative member. The OMB examines records from municipally owned organizations and is responsible for assessing the administration of municipal affairs within Toronto and the municipalities of Toronto and Halton. The OMB does not investigate allegations of wrongdoing, which remains the jurisdiction of the various city councils and police services in the City of Toronto. Councillor Farr was charged with four counts of financial misconduct: (i) MCC charged excessive and/or unauthorized travel and other expenditures to the credit card of its executive director; (ii) misappropriation of \$18,000; (iii) failure to properly maintain of \$5,000; and (iv) theft of \$1,000. Councillor Farr was discharged by a unanimous decision of the OMB Panel. The charges were withdrawn when it was decided that the OMB panel should make a decision based on the evidence presented at the hearing and not a pre-trial brief that was not submitted in this case. The four charges were listed in the pre-trial brief, which had no foundation in the law or in fact. The OMB Panel was comprised of members appointed by the Premier and a single independent member.
